

## THE MANHEIM GALLERY 2012 COMPETITION PROSPECTUS

**ELIGIBLE WORK** Original concept and design in any medium or mediums, the theme being **FOUR FEET & A TALE** or **FOUR FEET & A TAIL**. Artists should interpret "FEET" to imply either a measurement of inches or those human and animal parts, which allow us to walk. The same loose consideration should be given to "TALE" or "TAIL". Liberal use of imagination and humor is encouraged. Works previously shown or produced under supervision, such as in workshops or classes, are not eligible. **SIZE RESTRICTIONS** Minimum image size: 9" x 12" - Maximum image size: 24" x 36"

**JURYING/JUDGING PROCESS** All entries will be digital submissions. They may be on disk or as attachments to e-mails. Jurying will be completed by the judge based on the digital entries. Award winners will be selected by the judge before the show is hung. Judge to be announced.

**DIGITAL ENTRY FORMAT** Digital images may be submitted by e-mail to [pmanheim@msn.com](mailto:pmanheim@msn.com) or on a CD. Images must be sized at 72 dpi with no side longer than 6 inches. File names must adhere to following format:

**NOTIFICATION** Notification of acceptance will be by phone and email. Please insure this information is clearly and accurately printed on the Entry Form.

**ENTRY** All Entry Forms must be completed in full and be accompanied by a non-refundable check payable to THE MANHEIM GALLERY. The deadline for submission is no later than Saturday, February 15, 2012. The application requires a brief description of the entry/entries.

**FRAMING REQUIREMENTS** Juried entries presented for drop off at the gallery will be rejected unless they meet gallery standards:

1. They must be professionally framed, and matted, if appropriate, mounted, if required, free from defects, and suitable for hanging. SAWTOOTH HANGERS ARE NOT ALLOWED.
2. Each piece must have the artist's name, piece title and number, price and medium(s) on a piece of paper attached to the back of the piece.
